Result: Strategy of vol. 3, commitment of editorial board members and draft of calls

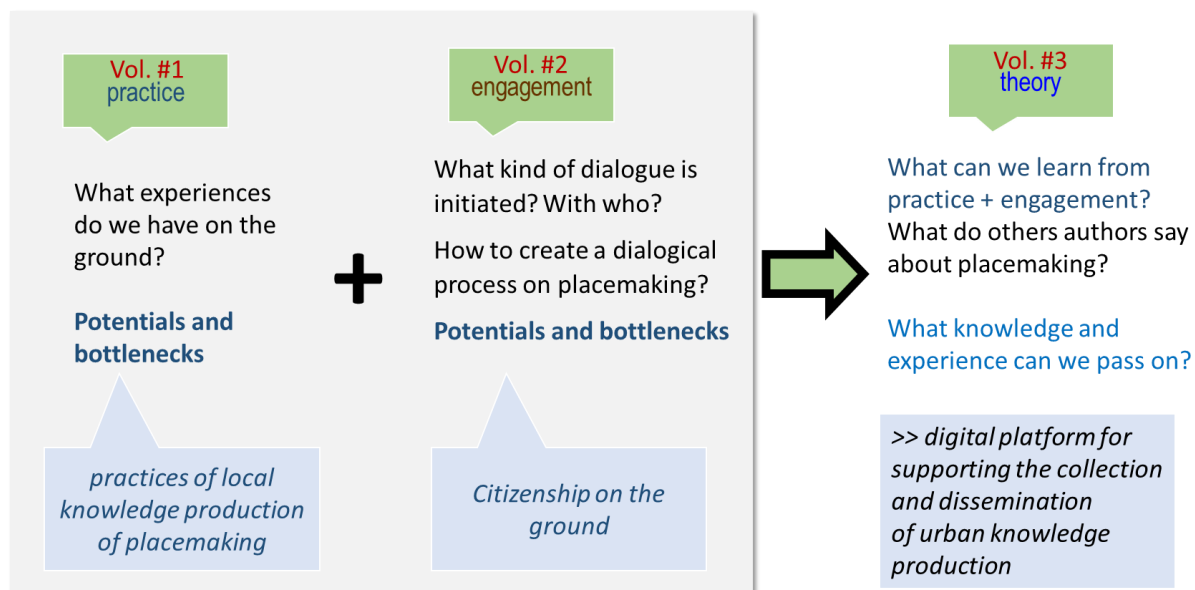

Editorial Process for all 3 volumes

1. Establish an **Editorial board** (to be composed by (i) **in-chief editorial team** (WG4 & WG3 & Chair) and (ii) **section editors** (different parts with 2 editors, always from different counties and backgrounds)
2. Launch **call for section editors** (who are in charge of coordinating the different parts/sections and will act as reviewer)
3. Establish the review process - ensuring peer review
4. Launch **calls for chapters** with agreed procedures and deadlines
5. Peer reviewed assessment and delivery of ready-to-print chapters by editorial board
6. Launch a **call for chapters** - define the scope and length of chapters
7. Chapters from collaborative work with at least 3 authors (each from a different country)
8. *Essays from external experts (proposing different/innovative views to the issues)*
9. **Define a timetable and review process**
